

Instructions for Completing the Application to Conduct an Open Fire

- 1. Property:** Provide the street address, city, state, zip code and property tax account number (from your property tax bill) for the property where the open fire is to be conducted.
- 2. Distance to Nearest...:** Provide distance to nearest occupied dwelling, and the distance to nearest public road and the name of that road for the property where the open fire is to be conducted.
- 3. Purpose:** Indicate whether the open fire is for demolition, land clearing, agriculture, recreational or other purposes.

If it is a recreational fire that includes the burning of untreated wood for pleasure, religious, ceremonial, cooking or a bonfire, you must provide the date and the type of event. For example: Halloween bonfire on October 31, 2006.

If a request is made to waive the required 1,500-foot buffer to an occupied dwelling or a primary road, you must indicate why.

Example 1: Request a waiver to burn at 600 feet with the aid of a pit and an Air Curtain Destructor (ACD).

Example 2: Request a waiver for agricultural, land, water or forestry management purposes.

You must submit a letter from the appropriate authority recommending the burning as an accepted management practice in agriculture or land, water or forestry management. Examples: Maryland Extension Service; Department of Natural Resources (DNR); Maryland Department of Agriculture; DNR Forestry; Maryland Department of the Environment (MDE) Water Management Administration.

- 4. Provide a detailed sketch of the property, including location of burn site.** Attach a property sketch or submit a detailed drawing of the property on page 3 (#18).
- 5. Name of Owner:** Provide name, phone number and mailing address of the owner/agent.
- 6. Read, sign and date the application.**

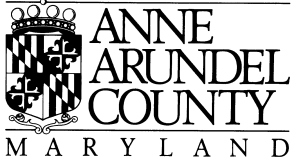

License To Conduct An Open Fire

The application, once approved, becomes the official **License to Conduct an Open Fire**. This License must be posted on the property where the open burning is being conducted and must be shown to County and State officials upon request. - X 1. Issuance of this license is conditional on the applicant's consent to inspections; that such inspections will focus on determining licensee's compliance with the laws and regulations related to the license; that inspections will be conducted at reasonable times unless the Health Officer has reason to believe that violations are occurring that can only be detected at other times; that failure to allow inspections may result in a Stop Work Order in addition to all other remedies permitted by law.
- X 2. The burning of tires is prohibited.
- X 3. Open fires cannot be conducted when a State or County Official announces that burning is prohibited in the interest of public health or safety. Advisories can be confirmed by calling:

- ___ 4. Burning shall be conducted only at the locations indicated on the property sketch attached.
- ___ 5. Only material originating on the property resulting from _____ may be burned. **Garbage, trash or other refuse may not be burned.** Material may not be allowed to smolder.
- ___ 6. Burning shall be conducted only between the hours of _____ and _____, provided that the wind velocity does not exceed 12 miles per hour.
- ___ 7. Burning shall be conducted for a period no more than _____ () hours.
- ___ 8. Burning shall be conducted at a minimum distance of _____ () linear feet from any neighboring occupied building or public thoroughfare and only when wind conditions are such that smoke emission will not be carried in the direction of either.
- ___ 9. Tree trunks greater than eight (8) inches in diameter shall be split prior to burning.
- ___ 10. Tree stumps greater than nine (9) inches in diameter shall be split prior to burning.
- ___ 11. An air curtain destructor shall at all times be operated in accordance with the attached Air Curtain Destructor (ACD) Operating Instructions.
- ___ 12. No burning on Saturdays.
- ___ 13. No burning on Sundays.
- ___ 14. You shall comply with Maryland Forest Regulations. Call the Anne Arundel County Forester at 410-360-8421.
- ___ 15. Bonfire shall be conducted on _____ only.
- ___ 16. You shall call A.A. Co. Fire Department Communications at 410-222-8200 prior to conducting burning on any day.

NOTE: You shall comply with Anne Arundel County Fire Department Regulations as follows:

- a) 10.11.2 Open Fires. All open burning shall be in compliance with Article 11, Title 5 of the County Code. **Open Fire Licenses shall be obtained from the County Department of Health and shall be kept at the burning site during burning operations.** Open burning operations judged to be in violation of the approved license, or that are judged to constitute a public safety hazard or public nuisance, shall be cause for suspension or revocation of the license and the fire shall be extinguished when so ordered by the **Incident Commander or Authority Having Jurisdiction (AHJ).**

This License shall be kept available on site at all times during burning operations and shall be shown upon request.

- b) 10.11.2.1 Permitted open fires shall be located not less than 50 ft (15 m) from any structure.
- c) 10.11.2.3 Recreational fires shall not be located within 25 ft (7.6 m) of a structure or combustible material unless contained in an approved manner.
- d) 10.11.2.4 Conditions that could cause a fire to spread to within 25 ft (7.6m) of a structure shall be eliminated prior to ignition (e.g. leaves, brush, dry grass). **Keep all accelerants at a safe distance of at least 50 feet from a structure.**
- e) 10.11.3 Open fires and cooking fires shall be constantly attended by a competent person until such fire is extinguished. This person shall have a garden hose connected to the water supply or other fire-extinguishing equipment readily available for use. A readily accessible means of notifying the Fire Department shall be provided at all times.
- f) 10.11.9 Discontinuance. The AHJ shall be authorized to require any fire to be immediately discontinued if the fire is determined to constitute a hazardous condition.
