Message from Acting Health Officer Douglas L. Hart

This Annual Report is designed to give you an understanding of how public health affects life in Anne Arundel County. With the support of County Executive John R. Leopold, the Department of Health is successfully meeting the public health needs of a changing and growing community. In Fiscal Year 2010, the Anne Arundel County Department of Health provided more than 1,400,000 personal and environmental health services directly to County residents and businesses.

The mission of the Department of Health is to preserve, protect and promote the health of all County residents. In fulfilling its mission, the Department assesses the County's health problems, needs and resources; organizes effective public and private sector strategies to address the needs; and provides services directly to County residents to achieve local health goals. County residents, private health practitioners, community organizations and government agencies are partners with the Department of Health in fulfilling this mission.

Based on community surveys and reviews of health data, the Department of Health has established five priority areas for addressing public health needs. These are:


- Preventing and managing chronic illnesses

SKIN CANCER PREVENTION

County Executive Leopold issued an Executive Order on March 15, 2010, to promote skin cancer prevention and sun safety awareness education in Anne Arundel County. As part of the Executive Order, the Department of Health provided thousands of skin cancer and sun safety materials to County tanning salons, parks, trails, pools, libraries and schools.



Preventing and Managing Chronic Illnesses

"Learn To Live" Healthy Living Program – Offers information and activities promoting healthy living to children, adults and families

- 13,880 kits distributed through the Learn To Live phone line and community events, including kits
 on smoking cessation, nutrition, sun safety, kids' health, Fifty-Plus health, and more
- 19,249 students educated about healthy eating and physical activity
- 16,741 youths educated about skin cancer prevention
- 10,150 consumers at 9 local supermarkets received healthy eating tips and sampled nutritious recipes

Tobacco Use Prevention and Cessation Program – Provides tobacco use prevention and cessation education and services

- 117,148 interactions with students through smoking prevention and cessation activities
- 223 adults participated in smoking cessation classes

Breast and Cervical Cancer Program – Partners with local physicians to provide education, free screening, diagnosis and treatment services for breast and cervical cancer to eligible women age 40 and older

• 1,240 women received education and initial screening

LifeScreen Colorectal Cancer Screening Program – Partners with physicians to provide colorectal cancer education and screening colonoscopies to eligible County residents 50 and older

153 individuals received initial screening

Community Drug and Alcohol Abuse Treatment Services – Provides drug and alcohol treatment referrals to a network of County providers

1,357 assessments and referrals provided through Opportunity for Treatment Funding (OTF)

Behavioral Health Services - Provides assessment and counseling to children and adults

- 383 children and adolescents received 2,936 individual and 3,212 family counseling sessions
- 536 adult addiction clients attended 5,329 individual, 801 group and 59 family counseling sessions

HIV/AIDS Prevention and Case Management Program - Provides HIV counseling and testing services

- More than 2,060 people were tested for HIV, and 65 HIV-positive individuals were linked to treatment and care
- 244 patients received HIV/AIDS case management services, and 7 HIV-positive pregnant women in the program delivered healthy HIV-negative babies

Being Prepared for Emergencies

Emergency Preparedness and Response – The Department of Health works with other County agencies and other health departments in the region in responding to natural or man-made emergencies. The Department is available 24 hours a day for public health emergencies through the Office of Assessment, Planning and Response.

 16,300 calls handled through the H1N1 flu information line, supported through the Office of the County Executive and the County Emergency Operations Center

Communicable Disease Surveillance Program – Collects, investigates and analyzes communicable disease data to alert physicians and the public to trends and unusual occurrences. When an outbreak occurs, appropriate action is taken to stop or control it.

2,074 investigations were conducted on reportable diseases



OPERATIONS STAFF AT H1N1 FLU VACCINE CLINIC NOVEMBER 2009

The Department of Health utilized the emergency management Incident Command System to plan and implement the well-organized, award-winning H1N1 flu vaccination campaign. The Department provided 27,097 free doses of H1N1 vaccine at 177 clinics around the County between October 2009 and March 2010.

Keeping Children Healthy

Immunizations Program – Ensures that children are immunized appropriately

- 6,369 routine immunizations administered to children
- 17,589 doses of seasonal FluMist vaccine given in public elementary schools, and 2,295 doses of seasonal flu vaccine given to children in clinics
- 14,777 doses of H1N1 flu vaccine given to individuals 6 months to 24 years old at health centers, schools and community settings

Healthy Babies Program – Provides information to pregnant women, parents and caregivers through the Healthy Babies Coalition, communication resources and community outreach activities

31,000 English and 15,000 Spanish resource information cards distributed to County residents

Women and Children's Health Services – Provides nutritional assistance, nursing services and selected clinical services

- 1,681 high-risk pregnant women received case management services from the Healthy Start program
- 14,697 clients served by the Women, Infants and Children (WIC) nutrition program

Dental Health Program – Provides dental care and education to low-income children and pregnant women

- 4,047 individual pediatric patients seen at the Annapolis and North County Dental Clinics and
 532 individual REACH program patients seen in the North County Clinic
- 3,904 schoolchildren participated in oral health education presentations

School Health Services – Provides nursing and other health services at the County's public and charter schools

- 659,050 student visits to school health rooms and 131,411 medications administered
- 22,371 vision screenings, 22,725 hearing screenings and 71,109 medical treatments given to County students

Reproductive Health Services – Provides maternity services, family planning services and education

- 3,274 clients received reproductive health services
- 164 births to maternity clients

Maintaining a Safe and Healthy Environment

Recreational Waters Monitoring – Tests water quality to prevent disease

• 3,171 water samples from the Chesapeake Bay and its tributaries were tested

Housing and Food Protection Services – Inspects food service facilities and ensures that food is prepared under safe and healthy conditions

- 4,243 food facility inspections conducted
- 1,460 housing-related inquiries and complaints handled

Well and Septic Program – Reviews plans for residential construction, tests well water quality and conducts soil evaluations and percolation tests to ensure proper sewage disposal in order to prevent disease and environmental harm caused by water contamination

- 526 septic system permits and 667 well permits issued
- 885 percolation tests performed

Chesapeake Bay Restoration Fund – Helps pay part or all of the costs to add environmentally-beneficial nitrogen-reducing pretreatment units to private septic systems

• 50 pretreatment units installed

Rabies Control Program – Distributes oral raccoon rabies vaccine throughout the County, investigates exposures to animals with suspected rabies and ensures treatment for persons possibly exposed to rabies

- 69,022 raccoon rabies vaccine baits distributed with support from Wildlife Services U.S.
 Department of Agriculture (USDA) and the County Police Department
- 1,388 potential rabies exposures investigated

Eliminating Health Disparities

Minority Health – Offers healthy lifestyle education and outreach to African-American, Latino-American and Korean-American communities

 4,360 minority individuals attended tobacco education sessions and 6,145 minority individuals attended cancer education sessions.

Strengthening Families Program – Provides training in parenting skills, life skills and family relationship skills for at-risk youth and their parents

229 family members graduated from the program

Maryland Children's Health Program (MCHP) – Processes applications for this medical assistance program for children up to age 19 and for pregnant women

■ 13,683 children and 1,490 pregnant women enrolled

Residents Access to a Coalition of Health (REACH) – Enrolls income-eligible uninsured adults in a program offering access to primary and specialty medical care and diagnostic testing at reduced cost

1,459 individuals enrolled and 524 health care providers participated

Prescription Discount Program (PDP) - Offers County residents discounts on prescription drugs

- 12,322 County residents had PDP cards for use at pharmacies nationwide
- 16,805 prescriptions filled using PDP cards

Medical Assistance Transportation Program – Provides transportation to non-emergency medical appointments for Medicaid recipients

35,679 client trips made



DEPARTMENT AWARDED GRANT FOR BREAST HEALTH PROGRAM

The Department of Health was awarded a grant by the Maryland affiliate of Susan G. Komen for the Cure. The Department's award of \$39,789 will fund Make a Promise to Yourself - Get a Mammogram, a partnership between the Department and local minority churches to host six breast health events to increase awareness of screening and to provide links to screening services.

MAJOR ACCOMPLISHMENTS IN FISCAL YEAR 2010

Flu Vaccinations

During Flu Season 2009-2010, the Anne Arundel County Department of Health provided more than 27,000 doses of H1N1 flu vaccine and more than 30,000 doses of seasonal flu vaccine at more than 200 clinics around the County.

Environmental Health

Effective October 1, 2009, the Department of Health implemented new requirements for the repair, replacement and installation of septic systems in the Critical Area as required by Senate Bill 554 (Chesapeake Bay Nitrogen Reduction Act of 2009). The Act requires a nitrogen-reducing unit when a replacement or new onsite sewage disposal system installation is made. Any portion of a property that falls within the Critical Area, which is all land within 1,000 feet of the high water line of tidal waters of the Chesapeake Bay and its tributaries, must comply with this act. The units reduce the amount of harmful nutrients, such as nitrogen, that septic systems discharge into the Chesapeake Bay.

Health Screenings

Through the Health Smart Church Program, 2,383 blood pressure screenings were completed. Through screening provided by the Breast and Cervical Cancer Program, a cervical cancer case and 12 breast cancer cases were detected. Through the LifeScreen Colorectal Cancer Screening Program, 3 colorectal cancer cases were detected.

Healthy Lifestyles

Information promoting healthy lifestyles is available on the Department's website, www.aahealth.org, which received 2,548,281 visits in Fiscal Year 2010. The Learn To Live Program continued the Web-based Family Fitness Challenge, which encourages adults and children to eat more fruits and vegetables and engage in regular physical activity.

Access to Health Care

The Residents Access to a Coalition of Health (REACH) Program, a partnership between the Anne Arundel County Department of Health and the County Medical Society, entered its tenth year of providing free or low-cost health services to income-eligible uninsured Anne Arundel County adults. In Fiscal Year 2010, 1,459 individuals were enrolled, receiving services from 524 providers including a partnership with the Kaiser Permanente Bridge insurance plan.

Minority Health

The Department's Office of Health Disparities continued to serve as the Department's liaison with the African-American, Korean-American and Latino-American communities. In collaboration with the County's Hispanic Health Network, the Department held Hispanic Girls' Night Out, a Spanish-language breast health event for women ages 40 and older.
