



### What We've Heard So Far

Highlights from the listening session discussions:

### **Community Awareness**

Education for birthing people to know when something is wrong and to self-advocate.

### **Drivers of Disparities**

Consider the social drivers and environmental factors that contribute to the health disparities.

### **Technology**

Promote an existing app with information for the birthing person and a way to track symptoms.

### **Provider Training**

Ensure providers are completing and applying implicit bias and cultural sensitivity training.

## 2024 Maryland General Assembly Highlights

HB0728 - Health Insurance - Qualified Resident Enrollment Program (Access to Care Act): By 7/1/25, the Maryland Health Benefit Exchange will submit a state innovation waiver application to establish a qualified resident program to allow qualified residents (lives in Maryland) to purchase plans on the exchange.

HB1333 - Public Health - Maryland Commission on Health Equity and Commission on Public Health - Revisions: The Maryland Commission on Health Equity is required to develop and monitor a statewide health equity plan AND examine the health of residents and ways for state and local government to collaborate and implement policies that with positively impact health. A report is due by October 1, 2025 to the Governor and the General Assembly.

SB0991 Behavioral Health - Language Assistance Services Pilot Program: Establishes the Language Assistance Services Pilot Program in the Behavioral Health Administration and provides local grants to reimburse behavioral health providers for language assistance services for children and their parents/ guardians making decisions.

## 2024 Maryland General Assembly Highlights

SB0119/HB0691: Legally Protected Health Care - Gender-Affirming Treatment: Adds "gender-affirming treatment", including medications and supplies, related to the direct provision or support of provision of care to the definition of "legally protected health care".

HB0522/SB0492: Public Schools - Student Telehealth Appointments: Requires MDH and State Department of Education to establish guidelines to accommodate students in middle and high school who need telehealth appointments during the school day.



# Cameron Carden Act

The Cameron Carden Act amends existing university policies to include mental health crises alongside physical injuries for student withdrawal and reimbursement.





#### WITHDRAWAL POLICY:

The bill requires each public institution of higher education in Maryland to adopt a policy allowing students to withdraw under certain circumstances, including mental health crises.

#### **EQUALITY FOR MENTAL HEALTH:**

The Cameron Carden Act ensures that students experiencing mental health challenges receive the same support and consideration as those with physical health issues.

### WHAT INSPIRED THE CAMERON CARDEN ACT?

The bill is named after Cameron Carden, a college student who faced racial discrimination and mental health struggles on campus. His story highlights the urgent need for improved mental health support in higher education.

### HOW DOES THE BILL BENEFIT STUDENTS?

The Cameron Carden Act provides a safety net for students facing mental health crises, offering them the opportunity to prioritize their well-being without fear of financial repercussions.
